Additional funding for cancer research and transportation costs for individuals to receive needed treatment. Provided funding for hippotherapy treatments to cerebral palsy patients. Funding enabled hospice organizations to provide end of life care and family counseling. Funding for juvenile diabetes research and patient support services.

Educational Funding

Provided grant funding to 86 teachers in various public school districts throughout Arkansas, Texas, Oklahoma and Louisiana. Funds were provided for basic school supplies, books, and equipment software, including new technology items needed in the classroom for enhanced learning.

Provided funding for spay and neuter programs for animal welfare program. Sponsorship and funding for court appointed advocates to help serve the needs of abused and neglected children.
