

Nonprofit VOTE partners with America's nonprofits to help people they serve participate and vote. We are the largest source of nonpartisan resources to help nonprofits integrate voter engagement into their ongoing activities and services.

Nonprofit VOTE worked to engage nonprofits on voting and elections. Our monthly webinars in 2016 reached over 2,500 nonprofit staff and leaders with legal how-to's, best practices, and planning tools around civic engagement. We updated and overhauled our heavily-used online resource library. We partnered strategically with United Way Worldwide to develop a Voter Engagement Toolkit that was distributed to United Way groups nationwide, while hosting webinars and workshops for a host of other key organizations and networks. Through our States Program, we worked with partners across 10 states to register or pledge to vote 40,000 individuals. The data from those efforts was collected and will be used for deeper analysis of our impact (report to be released in 2017). Finally, Nonprofit VOTE played a key role in organizing National Voter Registration Day in 2016 and recruiting over 400 nonprofit partners.
