

Baal Dan Charities ("Donation to Children" in Hindi) was formed to support the basic needs and social welfare of impoverished children (mostly orphans and street children) in Asia, Africa, North and South America. Given the vast number of impoverished children in these regions, Baal Dan's grants were primarily focused on India from 2006 to 2012. Since 2013, Baal Dan has provided grants for food, supplies and education in 12 different developing countries to projects that help vulnerable children, mostly orphans.

Baal Dan Charities focuses on identifying and vetting trustworthy organizations and partnerships that are child-focused and provide essential aid, shelter and education to vulnerable children, particularly orphans and street children.

In 2016, Baal Dan audited these organizations for their impact, transparency, and sustainability and provided specific grants for defined purposes such as food allocations, building projects (e.g. toilets) and education (e.g. school supplies, school fees).

Since Baal Dan's inception in 2006, over 250 organizations have been reviewed and of those in 2016, 6 were selected as recipients for grants and aid. These projects were held responsible for reporting the outcomes of the Baal Dan grant that was provided.

Baal Dan provided its donors with updates throughout the year via social media and an end of year e-newsletter. Baal Dan's accomplishments in 2016 include providing aid to approximately 385 children and an additional 500 children were impacted through multi-year grants already in place before 2016.

Since the inception in 2006, Baal Dan has a highly tested model of providing aid to vulnerable children in the care of grassroots projects in developing countries. This model has been proven effective and efficient with relatively low administrative costs and good oversight to ensure that the objectives and impact of all grants made are met. In 2016, Baal Dan launched "Food Mission, Serving Hope", a food and nutrition focused program to fund essential food, support the inclusion of protein-rich foods for children who are under-nourished or malnourished as well as additionally supporting basic needs for clothes, supplies, education and support for children.

In 2016, the following grants were made for very specific purposes:

Kenya: Provision of essential food, clothes and shoes for children

Honduras: Essential food for children

South Africa: Provision of essential food and support for children

Baal Dan raises money in the United States and then provides grants to projects in Asia, Africa, North and South America. Grants are allocated to orphanages, schools, charities, and grassroot projects that have been audited (personally visited) by a Baal Dan representative and meet certain requirements. Baal Dan works with these projects to best determine how to help these children in their care.

In order for a project to receive a grant application, certain requirements must be met. A grant application is required annually for each project. This application requires, among other things, a statement of the projects purpose and goals along with a brief description of sources of funds. The grant requestor agrees to use the funds provided by Baal Dan directly for the children it serves. It also agrees to provide written reports to Baal Dan as to the use of the funds as well as to maintain records and receipts for Baal Dan's review upon request. The projects selected for grants must allow unrestricted access to Baal Dan's representatives for purposes of project review, either through personal site visits, phone discussions, or e-mails. Also, each grant requestor must certify that it has not provided and will not provide support or resources to any individual or organization that advocates, plans, sponsors, engages in, or has engaged in any terrorist activity.

Once a grant request has been received, each request is reviewed and determined where the project is stable, reputable and in keeping with Baal Dan's purpose and goals. All grants over \$5,000 are approved by Baal Dan's Board of Directors. In most cases, funds are wired to the grant recipient.
