I would hope in the future there could be examples presented and more developed instructions shown on a website to help average people who have a small foundation to comply with the information you are requesting. This form appears to require me to sign under threat of penalties of perjury. I guess that I have unintentionally made some mistakes in filling out this form. Therefore, I must declare that I am not signing this form voluntarily, but signing it out of fear that if I did not, then I might be prosecuted.
