Maintained an arts center consisting of secondary auxiliary art gallery, ~~work spaces~~, artist work spaces, and facility for live presentations. The facility accommodates music, performance, video, and projected images.

Various events, live shows, music, workshops, lectures, guided meditational experiences were held throughout the year. An average of 4 per week with an average total attendance of about 100-150 persons per week.

About 18 artists, artists in development, and organizers of arts related activities occupied studios/work spaces throughout the year. Studios were opened to the public during Tucson Community-wide "ARTS WALK" and "OPEN STUDIOS TOUR" events. Workshops, events, presentations, etc. were also held by artists and others who were themselves the principle organizers. We do not have statistical data on all of these.

We are an art gallery & arts center dedicated to bringing the arts to the community. As an art gallery and arts center with auxiliary gallery, the buildings are integral to our exempt activities. Ten percent of occupancy is allocated to operational expense. The remainder of occupancy plus arts related expenses = \$ 168,171
