A week living among the poor for even just a week, gives a perspective for people for a life time. We spend our days serving the poor and in chapel services. The money is used to pay for food, lodging and transportation. In Part IX column 3a and Part IX 24a contain dollars spent for this program service.

4b (Code:) (Expenses \$ 13,179 including grants of \$) (Revenue \$)
Volunteers mentioned above work during the day in the Colosio neighborhood of Nogales, Mexico. This year we spent less because the majority of our cement was donated by another organization. We worked on retaining walls and painted several houses. The volunteers served food the children and hosted a carnival in our sports park. Part IX column 3a and part IX 24b contain dollars spent for this program service.

The volunteer mentioned about mostly serve in the summer time. However, Mexican leaders continue the work throughout the year. Three soup kitchens are open each week. We sponsor a soccer team. Each year we have a Christmas gift program for children. Some of this money was spent for medical needs of the families who assist us. Additional money was spent to improve our existing facilities and to buy food/clothing for the families of the Mexican leaders who work with us.
