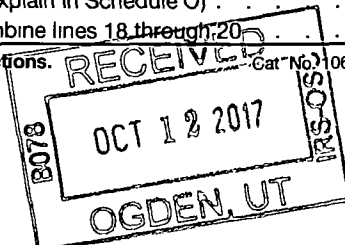

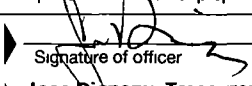

The organization, North American Arabidopsis Steering Committee (NAASC), was formed to forge relationships, foster communication among North American
scientists, and provide North American representation to the international community involved in research and education using the plant Arabidopsis thaliana.

Arabidopsis thaliana is a small flowering plant that is widely used worldwide as a model organism for basic research in plant genetics and molecular biology.

The function of NAASC is to serve as a liaison between members of the community and government and not-for-profit granting agencies, to provide
representation of the community to international research efforts and service facilities and initiatives such as ABRC, and to play a major role in planning, running,
and fundraising for the annual International Arabidopsis conferences. Members of NAASC also participate in domestic and international efforts involving plant
biology research and support of plant biology communities, especially Arabidopsis, research and support of plant biology communities.
