

**BICYCLE RECYCLING PROGRAMS**

Bike-Walk Alliance of NH supports and encourages organizations that provide bicycles at low or free rates to all persons who would like the opportunity to learn to cycle and/or need a bicycle as a means of transportation. Several organizations around the state including Laconia Area Bicycle Exchange, Central NH Bicycle Coalition and QC Bike Collective undertake various programs to obtain bicycles, repair them and make them available to the public. Income from the sales of these bikes is used to buy parts and accessories for the donated bikes.

**RAIL TRAIL DEVELOPMENT**

Expansion of the rail trail network throughout NH remains a major program for Bike-Walk Alliance. In 2016, our continued efforts resulted in the following accomplishments:

2) Friends of Salem Bike Ped Corridor worked with the Town of Salem to complete the first paved section of 1.2 miles thereby connecting to Windham & Derry for a total of 8.6 miles of paved rail trail.
