ACBS held an annual conference to educate psychologists in the areas of Acceptance and Commitment Therapy (ACT), Relational Frame Theory (RFT), and Contextual Behavioral Science, in Seattle, Washington, USA, in June 2016. The conference was organized by the ACBS Board, Executive Director, staff, and volunteer committees. This conference served to advance the science of psychology through a forum of presentations, workshops, and discussions. It aided psychologists and other mental health professionals in understanding principles that can be used to help their patients/clients. This conference drew approximately 1094 attendees from around the world. This activity was funded through conference registration fees.

ACBS maintains a website that serves to support the interaction between, and the education of, psychologists, students, and the public interested in contextual psychology/science, particularly ACT and RFT. This website helps to disseminate education resources among ACBS members as well as the general public. There were over 7743 website/ACBS members at the end of 2015. All potential conflicts are disclosed and discussed by the Board of Directors to determine if any further, or different course should be taken to ensure fair and equal treatment by the party in question. If the party in question is a voting member of the Board of Directors, they are required to abstain from deliberating on their own conflict issue, except to give testimony. Board members are required to sign the Conflict of Interest policy annually. To date, no conflicts have arisen to warrant follow up action by the Board of Directors.

Form 990, Part VI, Line 15a: The compensation for the position of Executive Director is reviewed and approved by the Executive Committee or a sub-committee of the ACBS Board of Directors. The Executive Committee is comprised of the President, President-Elect, Past-President, and Secretary-Treasurer. The Executive Committee annually performs a job competency evaluation, and reviews salary comparability data. The Executive Committee then compiles notes from all Committee members and makes recommendations for and approves any changes in compensation for the Executive Director. The Executive Director is the only key employee and no officers/directors receive compensation.
