The Cholangiocarcinoma Foundation is committed to providing services to patients and their families affected by this devastating disease. Both patients and the professional community are educated through our Annual Conference, website and book, 100 Questions & Answers about Cholangiocarcinoma. The Foundation also provides disease education, emotional support and a multitude of resources through a discussion board, social media sites, and responses to daily calls and emails. Through initiatives such as the Patient Registry, Action Alerts, and the Biliary Information Card, patients and their caregivers are given the opportunity to participate in research efforts while being empowered to take part in their own healthcare. The Organization also partners with similar organizations to spread awareness about the challenges faced by the rare disease community.

Form 990, Part III, Line 4b:

In 2016, the Cholangiocarcinoma Foundation awarded Research Fellowship Awards to four young investigators to raise awareness about cholangiocarcinoma and inspire innovative, quality research. In addition, a grant was awarded to the Mayo Clinic for the International Cholangiocarcinoma Research Network Biorepository (ICRN). The ICRN also hosted its first Industry Night event to partner with pharmaceutical companies invested in cholangiocarcinoma research. The Delphi Panel was a partnership with PHAR to assemble a panel of experts to develop consensus on managing emergencies in patients with biliary stents or tubes. Their work resulted in a poster presentation at a major oncology conference and is currently undergoing review for publication in a peer-reviewed journal. The Organization continues to focus on collaborative research efforts with the medical, scientific, academic, communities, government and its non-profit partners.
