Second Century Foundation conducts solicitation of funds for our mission on a continual ongoing basis throughout the year. Brochures are updated annually and distributed each Sunday. Once a year, Second Century is promoted from the pulpit of Trinity Church. An annual solicitation mailing is done in February every year. Sources of support come mostly from the membership of Trinity United Methodist Church, but donations are occasionally received from non-church members. Second Century has a Board of Directors that works to insure the growth of the corpus of investments, the assets. An investment policy is in place. The Board of Directors also works each year to make contributions to those entities in the Denver area that do the best job for the portion of the population who are in need of the most basic human needs, such as food, shelter and medical needs. Second Century Foundation in 2017 has begun an effort to broaden the donor base beyond the historic base in such a manner to ensure that public support will be increased. Those efforts are multi-faceted and have been effective at mid-year in helping to create one contribution of \$50,000. More success is expected.
