BECAUSE THE IGDA FOUNDATION'S PERCENTAGE OF PUBLIC SUPPORT IS ONLY 24.82% FOR THE YEAR ENDED DECEMBER 31, 2016, IT IS NOT PUBLICLY SUPPORTED UNDER THE 33(1/3) % TEST. HOWEVER, THE FOUNDATION QUALIFIES FOR PUBLIC CHARITY STATUS UNDER THE 10% FACTS AND CIRCUMSTANCES TEST BECAUSE THE IGDA FOUNDATION HAS DIVERSIFIED ITS SOURCES OF SUPPORT (AWAY FROM ONE LARGE CORPORATE SEED GRANT), THE FOUNDATION'S BOARD OF DIRECTORS REPRESENTS THE BROAD INTERESTS OF THE GAME DEVELOPMENT COMMUNITY, AND THE SCOPE AND IMPACT OF THE FOUNDATION'S PROGRAMS IS BROAD AND BENEFITS THE GAME DEVELOPMENT COMMUNITY AND THE PUBLIC AS A WHOLE. BEFORE 2015, THE IGDA FOUNDATION OPERATED WITH A MODEST BUDGET, USUALLY RECEIVING LESS THAN \$5,000 IN ANNUAL DONATIONS. HOWEVER, IN 2015, THE IGDA FOUNDATION RECEIVED SIGNIFICANT SUPPORT FROM INTEL, A CORPORATE SPONSOR. THE FOUNDATION HAS USED THIS INITIAL CORPORATE SEED FUNDING TO BUILD A LARGER, PUBLICLY-SUPPORTED CHARITY THAT MAKES A SIGNIFICANT IMPACT ON THE GAME DEVELOPMENT COMMUNITY AND THE PUBLIC. IN 2017, THE IGDA FOUNDATION IS ON TRACK TO RAISE OVER \$400,000 FROM MULTIPLE SOURCES TO SUPPORT ITS PROGRAMS, MORE THAN IN ANY PREVIOUS YEAR. ADDITIONALLY, THE SOURCES OF FUNDS HAVE DIVERSIFIED CONSIDERABLY, WITH NO SINGLE SOURCE CONTRIBUTING MORE THAN \$115,000, AND NO FUNDING SOURCE HAVING A RELATIONSHIP WITH THE OTHER. THE IGDA FOUNDATION ALSO MAINTAINS AN INDEPENDENT BOARD OF TRUSTEES, WITH NO MORE THAN ONE REPRESENTATIVE FROM ANY SINGLE COMPANY OR ORGANIZATION. THE IGDA'S BOARD OF TRUSTEES INCLUDES SEVEN (7) REPRESENTATIVES FROM SEVEN DIFFERENT GAMING COMPANIES OR ORGANIZATIONS THAT REPRESENT THE BROAD INTERESTS OF THE GAME DEVELOPMENT COMMUNITY. ADDITIONALLY, THE IGDA FOUNDATION PROGRAMS ARE RUN INDEPENDENTLY, AND HAVE GENERATED SIGNIFICANT AND LASTING CHANGE TO BENEFIT THE PUBLIC AND THOSE INTERESTED IN GAME DEVELOPMENT. THE VOLUNTEERS AND MENTORS WHO HELP RUN THE PROGRAMS INCLUDE PEOPLE FROM MANY MAJOR COMPANIES, WITH NO SINGLE COMPANY PROVIDING A MAJORITY OF VOLUNTEERS. OUR VOLUNTEERS ARE FREQUENTLY GAME DEVELOPERS AT THE PINNACLE OF THEIR PROFESSION. FINALLY, THE IGDA FOUNDATION MAINTAINS THREE PERMANENT PROGRAMS WHICH HELP TO SUPPORT A MORE DIVERSE AND INCLUSIVE INTERACTIVE ENTERTAINMENT INDUSTRY. *IGDA SCHOLARS BRINGS EXCEPTIONAL STUDENTS FROM AROUND THE WORLD TO MAJOR GAME DEVELOPMENT EVENTS, PROVIDING A TRAVEL STIPEND, EVENT ADMISSION, UNIQUE EXPERIENCES, AND AN INDIVIDUALLY-SELECTED MENTOR. IN 2017, THE IGDA SCHOLARS PROGRAM SUPPORTED 18 STUDENTS AT THE GAME DEVELOPER CONFERENCE IN SAN FRANCISCO AND 8 STUDENTS AT MELBOURNE INTERNATIONAL GAMES WEEK. *IGDA FOUNDATION WOMEN IN GAMES AMBASSADORS HELPS FEMALE STUDENTS EXPLORE GAME DEVELOPMENT AS A CAREER AT THE GAME DEVELOPER'S CONFERENCE. THE PROGRAM INCLUDES A TRAVEL STIPEND, EVENT ADMISSION, AND INTERVIEW SESSIONS WITH GAME DEVELOPERS, AND WELCOMED 20 PARTICIPANTS AT THE GAME DEVELOPER CONFERENCE IN 2017. *NEXT GEN LEADERS SUPPORTS THE RETENTION OF UNDER-REPRESENTED MINORITIES CURRENTLY WORKING IN GAME DEVELOPMENT THROUGH TWO DAYS OF PERSONAL AND PROFESSIONAL WORKSHOPS, ADMISSION TO THE GAME DEVELOPER CONFERENCE, A TRAVEL STIPEND, AND A MENTOR. IN 2017, TEN DEVELOPERS PARTICIPATED IN NEXT GEN LEADERS, WHICH LAUNCHED THAT YEAR.
