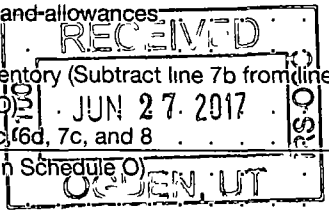

PART III STATEMENT OF 2016 PROGRAM SERVICE ACCOMPLISHMENTS (KENYA)

Give A Child Life's (GCL) mission is to help save the poorest children in the world at the time when it matters most, age five and under. In addition to providing low-cost, high-impact projects that transform communities, such as solar lights and bag gardens, GCL provides young children a safety net that includes feeding programs, emergency food and medicine, child care, preschool and Kids' Club. Mothers benefit from support groups, small business assistance, health training and hand-washing training. In 2016, GCL provided help to over 2000 families and 6000 children.

92 pre-and-post assessments showed that families with the longest participation in GCL had: a) significant increases in their weekly incomes, b) significant reductions in their children's hunger, and c) a greater percentage eating three meals a day.

The 2016 GCL core group consisted of 38 parents and 82 children age five or under. The poorest families in the community received a full spectrum of services including emergency food and medicine, vouchers for local infant care or preschool, participation in feeding programs, small business support and health training. They also were on our priority list for special projects, such as our solar lights and bag gardens. Other families in need received emergency food, medicine and other services as recommended by community leaders and GCL staff.

2016 GCL Feeding Programs provided

- Provided hot porridge and lunches for 28 children under 5 five days a week. Sick mothers and grandmothers joined as well.
- Fed about 120 children a day during the three months of school holidays.
- Supported 4 day care centers with breakfast for 125 children under age 3.
- Provided vouchers to preschools (with lunch!) for 46 children between ages 3 and 5 and (continued on next page)

- Gave emergency food packages to 138 families in crisis

2016 GCL Child Development Program

- Subsidized infant care and preschools for 76 children so mothers could work, and
- Involved 25 children in Kids' Club with games to increase cognitive skills, fine motor skills, number recognition, verbal skills, etc

2016 GCL Health Program

- Distributed liquid soap to 50 families and reduced the incidence of disease.
- Emergency medicine was provided to 65 children and 12 parents, and
- GCL paid hospital bills for several children

2016 Other Assistance

- GCL responded to 41 families in need throughout the year, assisting with rent, hospital bills, bus fare, small business support, etc
- GCL s helped 11 mothers gain skills to run their small businesses. They sell clothes, watermelon, bananas, porridge, eggs and chapattis.

Special Projects in 2016

- Installed 2731 solar lights made from recycled Coke Bottles to brighten homes and schools that were pitch dark during the day. To date, over 4000 solar lights have been installed, benefiting 3000 adults and 6000 children. (See details below)
- Built 500 DoorStep bag gardens overflowing with fresh vegetables and fruits, bringing the total number to 900+. Over 600 adults and 1800 children are healthier as a result, (See details below) and
- THE LATEST!!!! Introducing tortillas to Kenya. Children and families enjoy nutritious tortillas produced in the tortilla workshop that provides jobs for mothers and healthy food for all. (See details below)

SOLAR LIGHTS MADE FROM RECYCLED COKE BOTTLES. In Kenya, only 23% of the population has access to electricity. In the slums where we work, about a third of the families may have electricity, but they rarely use it and the wattage is low. The majority live in darkness with no windows. Mothers have mistakenly used fuel instead of water for cooking, children can't find things or see each other, and no one can read. For three years, GCL has been installing solar lights made from Coke bottles filled with water. Glued into a home's or school's ceiling, they cost almost nothing and will light up a room for years. So far, we've installed more than 4,000 lights. Evaluation results show the lights significantly improve the ability to see a person's face, read a book, find things, cook, and clean. Children and parents feel more secure and cockroaches, rats and snakes move out. Families also report saving a significant part of their small incomes. Many use the extra funds to pay school fees for older children or to buy more food.

DOOR STEP GARDENS. In Kenya's slums, homes are crowded together, with little space for gardens. Children eat mostly ugali, or corn meal with little nutrition. Over the past four years, GCL has installed 1,000 bag gardens in Kiandutu, changing the look of the community and

providing free vegetables to children daily. Evaluation data shows a) hunger has diminished and children no longer are malnourished.

and b) families save an average of 40 cents a week (a substantial amount for people living in desperate poverty).

TORTILLAS FOR KENYA! Our latest project is to bring tasty, nutritious tortillas to Kenya. Although Kenya's staple food is corn, nixtamalization (the process that changes it to form a dough) was never introduced. In February 2016, we took a wet maize hand-grinder and calcium hydroxide (slaked lime) to Kenya and taught mothers how to make tortilla dough. Our hope is to establish a cottage industry that will provide jobs for mothers and support GCL's feeding programs. Children will benefit, too, as tortillas have more niacin and calcium and are a more complete protein than untreated corn.

CHANGES IN 2016

- GCL works through Give A Child Life Kenya, a legally registered nonprofit. Our headquarters in Kiandutu, near Thika, is a major slum with 30,000. In 2016, we began working in nine other slums surrounding Nairobi, including Korogocho.

- To provide medicine more cost effectively and in a more timely manner, GCL has created a stockpile of basic medications, such as cough syrup, for sick children.

- Women in GCL's group took their first trip to visit a woman's group in another slum, Kibera, which is in Nairobi and one of the largest in the world. For many, it was their first trip out of Kiandutu in years.

EMERGENCY FOOD

In 2016, GCL provided \$1100 in emergency food to 138 families, about twice as much as was distributed in 2015. The average food package cost about \$3 and contained corn meal, flour and beans. Overall 356 food packages were provided, with more than half receiving only 1 package a year. The number per person ranged from 1 a year to 13 a year. Fifty seven percent of the distributions were to GCL members.

Due to the high rates of hunger in Kiandutu in 2016, GCL began providing small bags of the staple unga (corn meal) flour during each home visit, at GCL group meetings, and at Garden Club meetings.

EMERGENCY MEDICINE

In 2016, GCL provided emergency medicine to 77 individuals: 65 children, 9 parents, and 3 staff members, compared to 59 in 2015. In total, 91,180 ksh (\$912 compared to \$417 in 2015) worth of medicine was provided, averaging 628 ksh (\$6.28) each time. Overall medicine was provided 146 times, with most receiving it once. Two children received 5 prescriptions. 90% of the recipients were GCL members. On average, GCL provided 12 prescriptions a month, with February-July having the greatest need. Most of the prescriptions were for antibiotics or to fight respiratory diseases.

OTHER SERVICES

In addition to emergency food and medicine, GCL helps families in crisis, providing critically needed assistance targeted to individual needs. In 2016, GCL provided these services 56 times, compared to 100 times in 2015. The amount ranged from \$2.00 to \$160 to pay for a child's funeral. The most frequent need was for assistance paying rent, with the average support given of \$5.00. In all, 41 families were helped during 2016. The service provided followed by the number of times is as follows: Blankets 2, Bus fare 5, Business support 4, Chair 1, Counselor 1, Funeral 3, Hospital 2, House rent 19, Mattress and beddings 6, Post-natal supplies 1, Salon 2, Cooking pot 1, Training 1, Uniform (for work) 6, VCT (health testing) 1, Wedding card 1, and X-ray 1. Grand Total 56.

OTHER INFORMATION

GCL's compound is a real presence in the community, with demonstration gardens and Bulbs, and weekly garden trainings open to all. The large local health center, surrounded by our bag gardens and seed plots, hosts community demonstrations and provides our food to malnourished children. We work with government groups, churches, schools, etc. Health officials tell GCL about malnourished children needing gardens and TB victims needing the Bulb's UV light to kill germs. Government officials ask for gardens and Bulbs in schools and gatherings places.

All GCL leaders, including the CEO, are volunteers. The CEO, Deborah Johnson, spent 25 years creating, evaluating and managing children's social service and health programs around the world. For 4 years, she managed Feed The Children's programs in Kenya. Later she evaluated Los Angeles' Unified Early Education programs. Her Ph.D. is from Stanford. John Olson, special projects director, is an Orange County attorney with extensive volunteer experience in the U.S. and Mexico. The CFO, Melody McWilliams, is a business executive who maintains GCL's finances and has photographed our work in Kiandutu. Twenty volunteers handle mailings, assist with events, organize fundraisers, enter data and collect needed items.
