 Literacy Program: When the St. Louis Public Schools lost accreditation in 2007, the funding for libraries across the district stopped so focus and resources could be given to other areas. As a result, school library collections are aging, and periodical subscriptions were stagnant. The average collection age for an SLPS middle school is 1995. The Isaac Bruce Foundation has made a \$50,000 commitment to the SLPS to bring the libraries up to date and provide relevant, high-interest literature back to those libraries. In addition to the effort with SLPS, the Isaac Bruce Foundation proudly partners with Ready Readers to donate books to underserved preschool students in the St. Louis area in an effort to get students to love books at an early age. Reader Readers is a St. Louis nonprofit organization with a mission to inspire preschool age children from low income communities to become readers. In most cases, the donated books are the first book a child has of their own.

 Donations Program: The charitable merchandise program donates autographed items for other 501(c)(3) organizations. Donations were made to Joseph Prince Ministries to support their missions scholarship program. Donations were made to Bill Winston Ministries to support their business school scholarship program.

 Scholarship Program: The scholarship program began in 2008 and provides scholarships to students in St. Louis, Broward County, and University of Memphis annually. In order to apply for the scholarships, students must be college bound high school seniors and must have a minimum cumulative GPA of 2.0 (on a 4.0 scale).

 Free Football Clinic: Each summer, the Isaac Bruce Foundation hosts a free football clinic for St. Louis area kids. The free clinic provides youth the opportunity to work on their football skills, sportsmanship, and teamwork skills, while building self-esteem both on and off the field.

 Flight 300 Program: The Isaac Bruce Foundations Flight 300 Program provides transportation to college bound students in need. When Isaac graduated high school, he had a scholarship to a junior college in California, but he needed to find a way to get there.
