The ABF follows policies and procedures designed to maximize the effectiveness of grants, as well as ensure the grant funds are used for an exempt purpose. These policies and procedures are applied consistently for grants in and outside the United States. All grants go through a pre-grant inquiry process where the grantee is required to provide extensive information on its governance practices, financial policies and program activities in general, as well as with regard to the specific program for which it is requesting funding. A formal grant agreement is then executed and countersigned by the grantee and the ABF. The grant agreement specifies the amount of the grant, grant disbursement time line, any restrictions on the grant, as well as that the grant funds must be separately accounted for by the grantee. Grantees must report back to the ABF prior to receiving release of periodic grant installment disbursements. The ABF usually makes grants in several installments to ensure compliance with program, operational and accounting requirements by the grantee organization. The grantees provide interim operational and financial reports to the ABF. The reports describe the progress in achieving the grant objectives and include detailed accounting of the uses or expenditures of all grant funds. The program directors and the evaluation team of the ABF review the interim reports and conduct site visits to ensure that the progress indicated in the reports is correct. The ABF Finance and Compliance function reviews the interim financial reports and supporting records, such as invoices and contracts. The grantees provide a copy of audited financial statements for the accounting period covering the grant, if such are available. The grantees also submit a written report summarizing the project within two months after completion of the project in which they include a complete account of the expenditures of the grant funds and detailed description of the results and accomplishments of the grant. The grantees are required to keep financial records with respect to each grant along with copies of any reports submitted to the ABF or at least two years following the year in which all grant funds are fully expended. The ABF Audit Committee and Board of Directors exercise oversight over the grants disbursed through the review of reports and presentations by management.

Grants are reported consistent with the ABF's financial statements using the accrual method of accounting. Grant expenditures are recognized in the period the grant agreement is signed by ABF and the grantee, provided the grant is not subject to future contingencies. Conditional grants are recognized as grant expense and as a grant payable in the period in which the grantee meets the terms of the conditions. If payments of the unconditional promise to give are to be made to a recipient over several fiscal periods and the recipient is subject only to routine performance requirements, a liability and an expense for the entire amount payable is recognized. Investment expenses are reported consistent with the ABF's financial statements using the accrual method of accounting.

All companion travel serves a bona fide business purpose and, therefore, these expenses are excluded from the Director's taxable income as a non-taxable working condition fringe benefit. Accordingly, the ABF does not deduct its payments of the Director's companion travel expense on its tax return.

Family travel and housing allowance was provided to two US citizen employees who work for the ABF on a foreign assignment basis in Sofia, Bulgaria. All of these listed items, as provided by the ABF's Accountable Plan, are approved by the Board of Directors and are reported as taxable income on the employee's W-2.

**Part I Line 4a**

In connection with his separation of service in 2016, former ABF President George Zarubin entered into a Separation Agreement and General Release with ABF, pursuant to which he received a lump sum payment of \$132,500, reimbursement of certain moving and travel costs, and family healthcare coverage for six months post-termination. In consideration for the separation payment, expense reimbursement and insurance coverage, Mr. Zarubin agreed to a general release of any claims against ABF, a confidentiality covenant and a mutual nondisparagement covenant.

The Chief Financial Officer (CFO) is responsible for the preparation and the filing of the IRS Form 990 and all necessary extensions. The Form is completed by the Finance function of the ABF. As part of the preparation process, issues are discussed with outside legal and tax counsel and an external tax service consultant for nonprofit organizations. After a review by the CFO, copies of the Form are provided to the the president and the executive director of the Foundation for their review and feedback. A copy of the Form is distributed to the members of the Audit Committee of the board of directors. During a scheduled meeting of the Audit Committee, the CFO reviews the Form with the Audit Committee and any necessary changes are made. Before the Form is filed, a copy of the approved Form is provided to all officers and directors for their comments. The Form is then finalized and signed by the president or the CFO. After filing with the IRS, a copy of the signed Form is distributed to all directors.

Yes. Each year the directors, officers, and employees of the ABF review the Foundation's conflict of interest policy, disclose any conflict not previously disclosed, and update the status of any previous conflicts of interest reported in prior periods. No member of the Board of Directors of the ABF or any officer or management employee of the ABF shall originate, participate in, or vote on any transaction involving the ABF in which such person has a conflict of interest. In particular, a Director of the ABF shall recuse him/herself from the Board's deliberations regarding any matter in which the Director has a conflict of interest unless the Co-Chairmen or a Chairman of the Board determines that recusal is unnecessary in the particular instance. In addition, an employee shall not be the responsible staff person on a transaction in which he/she has a conflict of interest.
