Various programs including Online Auctions 2016 marked the 7th year of The Dale Jr. Foundation using eBay as a platform for online auctions. Each week, the Dale Jr. Foundation puts a minimum of three items on eBay. Most of the items are autographed by NASCAR drivers, for example, Dale Earnhardt, Jr., Chase Elliott, Regan Smith, Kevin Harvick, etc. Typically, the items are race-used memorabilia, die casts cars, posters, hats, and shirts. Throughout the year in 2016, TDJF offered 2 different race weekend experiences. These experiences include tickets and behind the scenes access at different race tracks, and meet and greets with JR Motorsports drivers. 2016 was the third year that The Dale Jr. Foundation auctioned off Dale Earnhardt, Jr. race worn driving gloves, with 100% of the proceeds benefitting Nationwide Childrens Hospital. Online auctions provide income to TDJF throughout the year. The eBay store can be found at <http://stores.ebay.com/The-Dale-Jr-Foundation>. Driven to Give Dinner and Auction In 2016, The Dale Jr. Foundation held the 6th annual Driven to Give Dinner and Auction. Driven to Give Dinner and Auction is an evening consisting of dinner, a live auction, silent auction, raffle, and entertainment for over 300 guests. The event was held at The Fillmore in Charlotte, NC and hosted by Dale Earnhardt, Jr. and Kenny Wallace with comedian guest Sinbad. The overall goal from the event is to raise funds for the charities supported by The Dale Jr. Foundation. Dale Jr. and Wallace held a live Q and A on stage, and introduced a video that educated guests on the initiatives and mission of The Dale Jr. Foundation, as well as recapped TDJFs overall efforts since inception in 2007. Ride Along Event 2016 marked the 8th year, The Dale Jr. Foundation has held its annual Ride Along event. This year 10 Ride Along packages with Dale Earnhardt, Jr. were sold for \$8,888 to TDJF partners, sponsors, and supporters. Throughout the year, these organizations use the packages as customer promotions, internal incentives, social media sweepstakes, and other initiatives. In October, the winners of each program are invited, with a guest, to race weekend in Charlotte. This year, the Ride Along event at Charlotte Motor Speedway occurred the Tuesday before the Charlotte races. The Ride Along event itself includes a Q and A session with Dale Earnhardt, Jr., a goody bag filled with exclusive items, a photo and autograph session with Dale and his car in Victory Lane, a DVD of the experience, and 3 laps around the race track with Tony Stewart and a 6 night stay at the Hampton Inn and Suites in Huntersville, NC. The winners are given tickets to the Cup and Xfinity races, as well as access to a pit and garage tour before the Xfinity race. The Ride Along event helps TDJF raise a significant amount of funds while giving fans, and supporters a chance to experience an awesome, once in a lifetime event.
