This program expense represents the costs for completing the construction of the New Joy House Orphanage in LaPlaine, Haiti.

The construction included the building of several dormitory buildings for housing boys and girls separately and in safety. Building the new facility also involved the construction of a large central building designed as a common area for meals, chapel services, and other special events. Construction costs included, masonry, plumbing, electrical, finishing, and painting.

4b (Code:) (Expenses \$ 69,462 including grants of \$) (Revenue \$)

The second largest program expense in fy2016 was the regular support of the La Plaine, Haiti orphanage operation. This support allows the Haitian partner organization to feed, clothe, house, educate, and safeguard 65 children who were formerly living as orphans out on the streets. With the construction of the new orphanage facility, we expect to increase the number of children cared for to nearly 100 in fy2017.

4c (Code:) (Expenses \$ 62,149 including grants of \$) (Revenue \$)

The third largest program category in fy2016 was for support of the medical clinic in La Plaine, Haiti, operated by our Haitian partner, Souls Winning Ministries. The clinic provide community health care in the La Plaine - Marin area (a suburban area of Port-au-Prince). This clinic is involved in combating the alarming rates of infant and expectant mother mortality in Haiti, as well as treating more general cases of diseases, injuries, and infections common to the Haitian tropical environment.
