TO SAVE ANIMALS AT RISK OF EUTHANASIA, CENTRAL OKLAHOMA HUMANE SOCIETY TRANSFERS THEM INTO ITS ADOPTION AND RELOCATION PROGRAMS. IN 2016, 3,501 DOGS AND CATS WERE PLACED INTO ADOPTIVE HOMES.

IN 2016, THE CLINIC PERFORMED 15,000 SPAY OR NEUTER SURGERIES AND OFFERED LOW COST VACCINATION SERVICES, MICROCHIPPING AND OTHER WELLNESS SERVICES. OUR IN HOUSE CLINIC SERVICES ANIMALS NEEDING ADDITIONAL MEDICAL ATTENTION. WELLNESS SERVICES. OUR IN HOUSE CLINIC SERVICES ANIMALS NEEDING ADDITIONAL MEDICAL ATTENTION.
