By highlighting the achievements of LGBTQ persons, Just Fund is able to educate the broader community, inspire youth and adults to persevere with their life goals, and this year to thank a philanthropist and activist who has given many years of service both to the LGBTQ community and to the Central Kentucky area at large through her numerous donations & sponsorships, entrepreneurial endeavors, volunteer service on nonprofit boards in the community, and her public service in the local government. As reported on the 990 Revenue Table, our total grants and contributions were \$519050. However, unusual grants must be excluded. We received two unusual grants. One was a grant of the remaining cash balance in the checking account of a c4 organization that dissolved. That amount was \$60636. The other was the proceeds of cashing out the investment portfolio of that same c4, the value of which on December 1st, the month of the withdrawal, was \$360138 per the investment account statement. Subtracting these two disbursements from the revenue total leaves \$98276 which is reported on the Part II table for 2016.
