The following information is submitted in accordance with Treasury Regulation Section 1.6043-3(a)(1) and the Form 990-PF instructions: During the taxable year ending December 31, 2016, the Foundation made distributions from assets from sources other than current income. Collectively, the distributions in excess of current income totaled \$107,000. This amount represents over 25% of the Foundation's net assets of \$187,257 (as measured by fair market value) at the beginning of the Foundation's taxable year ending December 31, 2016.
