The PINK Foundation operates after school programs and community based activities for children and families at risk

In 2016 the PINK program served 300 children weekly in 4 Bulgarian municipalities. Accomplishments include graduating the first class from our community cooking school in Tran, Bulgaria, adding a 4th location (Sofia, Bulgaria), and expanding our summer Olympic Games to 3 locations. In total we offered 26 after school activities in 5 age groups and held 9 week-long summer camps

Trivellius Institute is the largest protestant theological training college in Bulgaria. It has over 150 students studying theology and related disciplines for service to churches and other organizations throughout the Balkans. In 2016 the school introduced a new series of short term courses designed for ministry practitioners
