PROVIDENCE HOUSE DOMESTIC VIOLENCE SERVICES (PHDVS) - PEACE, A LEARNED SOLUTION (PALS) PROGRAM FOR CHILDREN, A PIONEERING PROGRAM RUN BY PROVIDENCE HOUSE IN BOTH OCEAN AND BURLINGTON COUNTIES, WAS SELECTED BY THE MARY BYRON PROJECT AS A 2016 RECIPIENT OF THEIR CELEBRATING SOLUTIONS AWARD. THIS PROGRAM WAS ONE OF ONLY THREE SELECTED NATIONALLY. THE MARY BYRON PROJECT WAS ESTABLISHED IN MEMORY OF MARY BYRON WHO WAS TRAGICALLY MURDERED 23 YEARS AGO. THE PROJECT HAS BECOME NATIONALLY RECOGNIZED AS A THOUGH LEADER ON DOMESTIC VIOLENCE AND FOCUSES ON "SUPPORTING AND RECOGNIZING INNOVATIVE EFFORTS THAT ATTACH THE ROOT CAUSES OF DOMESTIC VIOLENCE TO HELP BUILDING SAFER, HEALTHIER COMMUNITIES." NOMINATIONS FOR THE CELEBRATING SOLUTIONS AWARDS ARE JUDGED BY A PANEL OF EXPERTS IN CRIMINAL JUSTICE, HEALTHCARE, AND PUBLIC POLICY. INCLUDED IN THE AWARD IS A \$10,000 GIFT AND A SITE VISIT FROM KEY OFFICERS AND PANELISTS FROM THE MARY BYRON PROJECT. PROVIDENCE HOUSE DOMESTIC VIOLENCE SERVICES PROVIDED THE FOLLOWING IN 2016: 332 VICTIMS AND THEIR CHILDREN WERE PROVIDED SHELTER SERVICES, 3,294 CALLERS TO THE HOTLINE WERE ASSISTED, 4,578 UNDUPLICATED INDIVIDUALS WERE PROVIDED ASSISTANCE THROUGH ONE OR MORE OF PHDVS' PROGRAMS, 6,276 INDIVIDUALS RECEIVED DV EDUCATION AND/OR TRAINING THROUGH STAFF PRESENTATIONS, INCLUDING 262 TRAINING SESSIONS.
