The Olympic Games and Paralympic Games in Rio capped off the quadrennial with some exciting achievements, with all Olympic disciplines capturing a medal. The Show Jumping Team of Kent Farrington, McLain Ward, Lucy Davis and Beezie Madden won the Team Silver, narrowly missing the Gold. The Dressage Team of Steffen Peters, Laura Graves, Kasey Perry-Glass and Allison Brock exceeded expectations and showed us what team work, talent, and a strong work ethic will do, winning the Team Bronze, with Laura Graves posting a personal best score of 80.644 and finishing in 4th place individually. In Eventing, Phillip Dutton showed his experience and talent with a gutsy and strong cross country ride, to capture the Individual Bronze Medal. The team of Phillip Dutton, Boyd Martin, Lauren Keiffer and Clark Montgomery realized two eliminations on cross country, putting them out of medal contention. Our Para-Dressage riders Rebecca Hart, Angela Peavy, Sydney Collier and Margaret McIntosh continued to progress and gain necessary experience at an international championship. This experience will help to prepare them, as well as show them, what it will take to reach the podium at the 2020 Tokyo Paralympic Games. In 2016, the USET Foundation provided approximately \$3,941,000 in grant funding, the largest grant to date, representing over 50% of their program budget. This funding was possible due to a successful "Rockin Rio" benefit with Honorary Chairs, Patti Scialfa and Bruce Springsteen, as well as gifts to the Campaign for Continuing our Competitive Excellence, and the loyal annual support from our Gold Medal Club members. The Human Sport Science and Medicine Program (HSSM) established last year, proved to be a critical component of the success for several of our Olympic and Paralympic athletes in Rio. We are grateful to Betsy Juliano for her commitment in helping support this pilot program, which will now become a permanent part of the Federations High Performance program. The Hamilton Farm stables and facility in Gladstone continued to serve our athletes for training, competition and as a place to gather prior to shipping overseas. Additionally, Hamilton Farm is the headquarters for the USET Foundation and houses some of the Federations High Performance offices. Next year, the stable will celebrate its 100th anniversary and its extraordinary place in the history of equestrian sport. The High Performance Programs and the achievements of our athletes and teams are only possible through the wonderful horse owners and supporters of the USET Foundation, always loyal and generous in their philanthropy, who share our passion for ensuring our United States equestrian teams have the resources necessary to be competitive on the world stage.
