Expenses include subsidies and direct financial assistance that make participation possible for 20% percent of the young people we engage. Our YMCA is committed to nurturing the potential of every child and teen. We believe all kids have great potential and deserve the opportunity to discover who they are and what they can achieve. That's why we help young people cultivate the values, skills and relationships that lead to positive behaviors, better health and educational achievement.

Healthy Living - In 2016, we provided \$308,223 in financial assistance and subsidies to people who otherwise may not have been able to afford to participate. The Y is committed to improving Americas health and well-being, community by community. As a result, over 11,200 people in our community are receiving the support, guidance and resources they need to achieve greater health in spirit, mind and body. This is particularly important as our nation struggles with chronic disease and obesity, families wrestle with work/life balance and individuals search for personal fulfillment. Our programs are accessible, affordable and open to all faiths, backgrounds, abilities and income levels.
