Spirit Soccer of Chester County fields up to three teams per age group so that more than just the top level players can have the opportunity to play against other clubs. Some Spirit Soccer Club of Chester County teams have traveled to places such as Dallas, Florida, Phoenix and Sweden. In 2016, over 60 Spirit Soccer Club of Chester County alumni will be playing at the college level.

Spirit Soccer Club of Chester County soccer tournament is the largest in Pennsylvania. It attracts teams from throughout the Northeast. The tournament, for girls and boys U-9 through U-16, occurs over two weekends in August.
