The Cathedral Soup Kitchen serves the poor and homeless of the Camden, NJ area. It serves meals Monday through Saturday, in 2016 over 130,000 meals were served. CSK also provides meals to local shelters and halfway houses pursuant to contracts with other local agencies. Free and reduced fee health and dental care are available to Camden residents, local partners provide the services at the CSK site. CSK also operates a Culinary Arts Training Program that trains impoverished individuals. Two 17 week classes are held each year. CSK also provides off site catering services in conjunction with its Culinary Arts Training Program. All income derived from the catering and contracts are used to support other CSK programs.
