Training for Organizations Beck Institute sends lecturers and keynote speakers around the U.S. and the world to present half-day to full-week workshops for mental health and related organizations. Speakers offer a wide range of Cognitive Behavior Therapy topics, focusing on the practical application of Cognitive Behavior Therapy and including tailor-made programs (that may include but are not limited to didactic presentations, multimedia, demonstrations, and role-plays) based on the needs of the specific organization requesting training. In 2016, a total of 1,210 trainees from organizations in 14 states, as well as in Brazil, Canada, the Dominican Republic and Ecuador received training Supervision and Consultation. In 2016, a total of 21 supervisees came from seven different states, as well as from the following countries: Canada, Hong Kong, Thailand, Lebanon, Japan, and Jamaica. There were also two consultation groups of 14 trainees from two states. On the Road Workshop Beck Institute implemented On the Road workshops with the intention of making our in-person training, historically only available in Philadelphia, more convenient to trainees by making them available on a more regional level. In 2016, a total of 135 trainees came from 23 states and the following 4 countries: Canada, India, Nigeria and United Arab Emirates. Diet - In 2016, Beck Institute treated 46 clients and conducted 743 client sessions. Beck Institute also held one 2-day diet workshop for 41 attendees. Publication revenue is revenue received for the sale of CBT educational materials such as books, CDs and DVDs.
