LOAN REPAYMENT ASSISTANCE PROGRAM IN SEPTEMBER OF 2010, THE PENNSYLVANIA BAR FOUNDATION, IN CONJUNCTION WITH THE PENNSYLVANIA IOLTA BOARD, LAUNCHED A LOAN REPAYMENT ASSISTANCE PROGRAM FOR ATTORNEYS EMPLOYED BY IOLTA-FUNDED ORGANIZATIONS THAT PROVIDE FREE CIVIL LEGAL AID TO INDIGENT PENNSYLVANIANS. THE PROGRAM HAS TWO GOALS: 1) TO ASSIST LEGAL AID ATTORNEYS IN BETTER MANAGING THEIR EDUCATIONAL DEBT SO THEY CAN AFFORD TO CHOOSE AND REMAIN IN PUBLIC SERVICE CAREERS, AND 2) TO HELP CIVIL LEGAL AID ORGANIZATIONS ATTRACT AND RETAIN SKILLED AND TALENTED LAWYERS IN PUBLIC SERVICE. STOUTT MEMORIAL SCHOLARSHIP FUND OF THE PENNSYLVANIA BAR FOUNDATION AWARDS MODEST SCHOLARSHIPS TO PENNSYLVANIA RESIDENTS ATTENDING ANY ONE OF THE NINE ACCREDITED LAW SCHOOLS SERVING PENNSYLVANIA. THE SCHOLARSHIP FUND IS SUPPORTED BY THE NET PROCEEDS OF AN ANNUAL SILENT AUCTION. IN 2016, THE FOUNDATION AWARDED THREE \$3,000 SCHOLARSHIPS. THE SCHOLARSHIPS ARE AWARDED COMPETITIVELY, BASED ON THE APPLICANT'S ACADEMIC PROGRESS, FINANCIAL NEED, RECOMMENDATIONS, AND POTENTIAL FOR MAKING A CONTRIBUTION TO THE LEGAL PROFESSION EITHER THROUGH ANTICIPATED LEGAL WORK OR OTHER EFFORTS AS DISCUSSED IN THE APPLICANT'S 250 - 500 WORD ESSAY. TWO OF THE SCHOLARSHIPS ARE SPECIFICALLY DEDICATED TO THE SUPPORT OF HISTORICALLY UNDERREPRESENTED MINORITY LAW STUDENTS. THE PROGRAM HAS AWARDED MORE THAN \$150,000 SINCE ITS INCEPTION IN 2003, HELPING MORE THAN 100 PENNSYLVANIA LAW STUDENTS OFFSET SOME OF THE COSTS ASSOCIATED WITH THEIR LAW SCHOOL EDUCATION.

NAMED SCHOLARSHIP - IN 2013, THE PENNSYLVANIA BAR FOUNDATION LAUNCHED A NAMED SCHOLARSHIP PROGRAM TO PROVIDE INDIVIDUALS AND ORGANIZATIONS WITHIN AND BEYOND THE LEGAL COMMUNITY THE OPPORTUNITY TO ESTABLISH AN ANNUAL SCHOLARSHIP TO BENEFIT PENNSYLVANIA RESIDENTS ATTENDING ANY ONE OF NINE ACCREDITED LAW SCHOOLS SERVING THE STATE. AN ANNUAL MINIMUM COMMITMENT OF \$3,000 PER YEAR FOR FIVE YEARS IS REQUIRED TO ESTABLISH A NAMED SCHOLARSHIP FUND.
