IN ORDER TO ENSURE THE SUCCESSFUL EXECUTION OF THE ORGANIZATION'S STRATEGIC DIRECTION AND LONG TERM GOALS, THE EXECUTIVE COMMITTEE OF THE BOARD OF DIRECTORS, WITHOUT THE PARTICIPATION OF THE PRESIDENT AND CEO, WILL ANNUALLY EVALUATE HIS/HER PERFORMANCE. THE CHAIR OF THE BOARD OF DIRECTORS WILL ASK THE PRESIDENT AND CEO FOR INPUT CONCERNING ORGANIZATION ACCOMPLISHMENTS AND PERSONAL PERFORMANCE FOR THE PRIOR YEAR AS WELL AS REQUESTS FOR CHANGES IN HIS/HER COMPENSATION. THE EXECUTIVE COMMITTEE WILL SECURE RELEVANT INFORMATION TO SET THE COMPENSATION OF THE PRESIDENT AND CEO TO THE EXTENT FEASIBLE. SUCH INFORMATION SHOULD DOCUMENT COMPENSATION LEVELS INCLUDING SALARY AND BENEFITS OF INDIVIDUALS WHO POSSESS SIMILAR QUALIFICATIONS AND RESPONSIBILITIES. THE EXECUTIVE COMMITTEE MAY ALSO CHOOSE TO CONSIDER ADDITIONAL FACTORS IN SETTING COMPENSATION SUCH AS, BUT NOT LIMITED TO, LENGTH OF SERVICE, ORGANIZATIONAL GROWTH, AND SUCCESS IN PERFORMING DUTIES. THE COMMITTEE WILL DOCUMENT AND RECORD DELIBERATIONS AND DECISIONS REGARDING COMPENSATION ARRANGEMENTS FOR THE PRESIDENT AND CEO. THE CHAIR OF THE BOARD OF DIRECTORS, WHO IS A VOLUNTEER AND NOT COMPENSATED BY PPC, WILL OPERATE INDEPENDENTLY, WITHOUT INFLUENCE FROM THE PRESIDENT AND CEO. NO MEMBER OF THE EXECUTIVE COMMITTEE INCLUDED IN THESE DELIBERATIONS WILL BE A STAFF MEMBER, THE RELATIVE OF A STAFF MEMBER, OR HAVE ANY RELATIONSHIP WITH STAFF THAT COULD PRESENT A CONFLICT OF INTEREST. LINE 15B - THE PRESIDENT AND CHIEF EXECUTIVE OFFICER (CEO) WILL NOTIFY THE CHAIR OF THE BOARD OF DIRECTORS IF ANOTHER EMPLOYEE HAS EARNINGS REACHING THE IRS DETERMINED THRESHOLDS OF "KEY EMPLOYEE." IN THIS CASE, COMPENSATION WILL BE SET FOR THE "KEY EMPLOYEE" IN A MANNER SIMILAR TO THAT OF THE PRESIDENT AND CEO. THE PRESIDENT AND CEO WILL PARTICIPATE IN THE EVALUATION AND COMPENSATION DETERMINATION FOR THE "KEY EMPLOYEE" PENDING NO CONFLICT OF INTEREST.
