This is accomplished by the giving of numerous public concerts throughout the year at which contributions are solicited. In addition, each year, a national classical music performance competition is held which produces revenue from are solicited. In addition, each year, a national classical music performance competition is held which produces revenue from (1) contributions of attendees, (2) fees from the competitors, and (3) ads in the programs. The first of these qualifies as public contributions, reported on Line 1 of Part II. For the years 2012 through 2015, we did not hold the competition, because of general economic conditions. This has resulted in a decrease in Line 1. We also participate in a township monthly Friday night tour of the business community, called "First Friday", for which we hold a concert. We are thereby able to solicit contributions from the public that may not normally attend our other concerts. These "First Friday" events are no longer held. We are introducing a public concert series to replace these events. Our general public contributions, outside of these special events, has also fallen over the past several years, we believe, because the competitive environment for contributions to the arts has also intensified. With an improving economy, we expect to see our contributions from the general public increase as well.

Scholarship and Financial Aid Policy of the NBS Classical Music Institute. The following non-discriminatory policy applies to all grants and awards:

1. There will be no discrimination among candidates on the basis of race, color, national or ethnic origin.
 2. The Institute's Board of Directors will appoint a committee to administer these grants and awards. The committee will determine whether the student or family is to receive an award and the size of the grant. There will be two types of Scholarship Grant: The first is a monetary grant for partial or full tuition, which is given if the award criteria are met and the parent(s) express need with evidence thereof. This may include a tax return or a letter stating the family circumstances that lead to this need. The second is an honorary scholarship award, which is given if the award criteria are met and the parent(s) do not express need. An honorary award certificate is given instead of the cash award.
- Criteria for Award: 1. In all cases the student must be judged by the committee to have musical talent. 2. One or more of the following criteria may be applied:
- (a) The student is already taking lessons and needs longer or more lessons.
 - (b) There are multiple children who desire lessons and the parent(s) express need in order that all children can take lessons.
 - (c) The school has a need for specific instruments in order to enrich and strengthen the entire curriculum. Examples of such instruments are viola, cello, double bass and clarinet.
 - (d) There is a need to promote or enrich special programs such as chamber and theory
