NOCSAE funded research resulting in the publication of more than twenty peer-reviewed scientific journal articles on the topic of concussions in sports, injury epidemiology, and equipment performance. In addition, the Center for Injury Research and Policy at Nationwide Children's Hospital in Columbus, Ohio, in affiliation with Ohio State University, maintains a high school sports injury surveillance program and publishes results of that data with significant grant support from NOCSAE. NOCSAE also assisted with the establishment of athletic equipment standards through related research. On the basis of grant funded research, and direct contracted research, NOCSAE has drafted three new standards for baseball and softball protective headgear and face gear for defensive players, is investigating a youth football helmet standard and has one draft for consideration, and is investigating the feasibility of a lacrosse helmet standard for women.
