These children came from 9 counties in Eastern Nebraska, representing approximately 10% of the counties in the state. The governing body consists of citizens from Omaha and Ralston, NE and Council Bluffs, IA. Widespread support of this organization is accomplished in a multi-county area of Eastern Nebraska and Western Iowa. Six of the nine board members are elected yearly. Two board members serve one year terms and four board members may be re-elected up to three years. The final three members are appointed by the Cathedral Board. These appointments may be but not necessarily are a member of the Cathedral Board. At present there are two from the Cathedral Board and one is not.

Widespread support of this organization is accomplished in a multi-county area of Eastern Nebraska and Western Iowa. Six of the nine board members are elected yearly.
