SPECIAL OLYMPICS VERMONT ("SOVT") IS PART OF A GLOBAL MOVEMENT THAT WORKS YEAR ROUND TO FOSTER INCLUSION AND ACCEPTANCE OF PEOPLE WITH INTELLECTUAL DISABILITIES BY USING THE POWER OF SPORT TO SHOWCASE THEIR GIFTS AND ABILITIES. OUR MOVEMENT IS INSPIRED DAILY BY THE ACHIEVEMENTS OF OUR ATHLETES ON AND OFF THE PLAYING FIELD. CURRENT YEAR HIGHLIGHTS AND ACHIEVEMENTS INCLUDE THE FOLLOWING: AN ATHLETE FROM RUTLAND, VERMONT WAS ONE OF TEN SPECIAL OLYMPICS ATHLETES NATIONALLY CHOSEN TO COMPETE IN THE SPECIAL OLYMPICS UNIFIED SNOWBOARDING RACES AT THE 2016 X GAMES IN ASPEN, COLORADO. TIM SHRIVER, THE CHAIRMAN OF SPECIAL OLYMPICS, INC., ATTENDED THE 2016 SPECIAL OLYMPICS VERMONT WINTER GAMES AT SUICIDE SIX SKI AREA IN POMFRET, VERMONT. A UNIFIED TEAM COMPRISED OF ATHLETES AND PARTNERS FROM BENNINGTON WAS ONE OF ONLY 32 TEAMS FROM AROUND THE COUNTRY SELECTED TO COMPETE IN THE 2016 SPECIAL OLYMPICS NORTH AMERICA SOFTBALL INVITATIONAL TOURNAMENT IN VIRGINIA. THEY EARNED 2ND PLACE IN THEIR DIVISION. AN ATHLETE FROM FAIRFAX, VERMONT COMPLETED THE HALF-MARATHON IN THE 2016 VERMONT CITY MARATHON. ATHLETE PARTICIPATION GREW TO 1,320 INDIVIDUALS IN 2016 - A 16.3% INCREASE OVER THE PREVIOUS YEAR. SPECIAL OLYMPICS VERMONT WELCOMED 275 PARTICIPANTS TO THE "YOUNG ATHLETES" PROGRAM ACROSS THE STATE IN 2016, SIGNIFICANTLY EXPANDING THE PROGRAM FROM 18 PARTICIPANTS IN 2015. SPECIAL OLYMPICS UNIFIED CHAMPION SCHOOLS IS AN EDUCATION AND SPORTS BASED STRATEGY POWERED BY AN ENGAGED YOUTH COMMUNITY THAT INCREASES ATHLETIC AND LEADERSHIP OPPORTUNITIES FOR STUDENTS WITH AND WITHOUT INTELLECTUAL DISABILITIES, WHILE CREATING COMMUNITIES OF ACCEPTANCE FOR ALL. OUR HEALTHY ATHLETES PROGRAM PROVIDES HEALTH SCREENINGS TO ATHLETES DURING COMPETITIONS. PROGRAM GOALS ARE TO EDUCATE ATHLETES ABOUT HEALTHY LIFESTYLES, IMPROVE ACCESS TO CARE, MAKE REFERRALS FOR FOLLOW UP CARE, TRAIN CURRENT AND FUTURE HEALTHCARE PROFESSIONALS TO INTERACT WITH PEOPLE WITH INTELLECTUAL DISABILITIES, AND ADVOCATE FOR IMPROVED HEALTH PROGRAMS FOR THOSE WITH INTELLECTUAL DISABILITIES.
