 Health Education - The Annex Teen Clinic provided health education and outreach presentations to 4,539 individuals in 2016. This represents unique or unduplicated individuals. Of the 4,539 youth served 94% demonstrated an increased knowledge about pregnancy prevention, STI and HIV prevention and increased confidence about making changes in behaviors to improve their sexual health.

 Clinic - The Annex Teen Clinic provided confidential, sexuality related clinical services to 1782 adolescents and young adults in 2016. These clinic patients were seen for a total of 4,004 visits. 100% of all clinic patients were screened for sexually transmitted infections according to protocol and 100% of those testing positive were treated. 87% of those clinic patients seen for birth control/contraceptive services were compliant with their chosen method and did not experience an unintended pregnancy.
