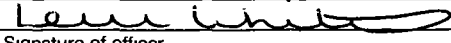

Applicants are prioritized according to the selection criteria, with ten awards made over the two National Convention meetings. The Division also awards eight \$1,000 Junior Faculty Excellence Awards. At four awards per National Convention, these are provided to tenure-track junior faculty with excellent emerging research programs as determined by a panel of judges selected by the Executive Committee of the ACS Division of Computers in Chemistry.

The ACS Computers in Chemistry Division does not discriminate on the basis of race, religion, sexual orientation, physical disability or gender.
