Rent/Mortgage assistance for pregnant women and mothers with infants up to three months of age. Homelessness is avoided and mothers are able to maintain doctor-ordered bedrest because of Cradle of Hope's assistance with rent/mortgage payments. In 2016, 395 women were assisted with a total of \$296,547 for rent/mortgage when pregnancy related financial challenges threatened their stability. This critical program has immeasurable health benefits for both mother and child by providing shelter and promoting full term pregnancies.

Cradle of Hope's Safe Slumber Program. The probability of infant mortality is lessened due to Cradle of Hope's Safe Slumber Program which distributed 1090 portable cribs in 2016. In addition to the portable cribs, each client also receives a safe sleep sheet set and safe sleep information so each client can ensure a safe environment for their baby. Mothers benefit from the program because their babies are secure in a safe environment which reduces stress and empowers them to become hopeful about their future.
