1 Briefly describe the organization's mission: The Historic Natchez Foundation's mission is to foster, encourage, and engage in the preservation, restoration, and development of historic or important sites, buildings, and personal property, in every way deemed to be feasible, including acquisition of buildings, sites, and other property for preservation and restoration and establishment of a revolving fund for this purpose.

4a (Code:) (Expenses \$ 97,522 including grants of \$) (Revenue \$ 1,669) EDUCATION-Information related to Natchez regional history, genealogy, architecture, and decorative arts is provided on a daily basis to local citizens, governmental and other organizations, visitors, scholars, writers, genealogists, historical associations, museums, filmmakers, and others. The staff lectures and consults on Natchez history; historic preservation; architecture; archival and collections management; decorative arts; landscapes; and gardens to local citizens, local and visiting organizations, and to tourists. The Foundation opens its headquarters five days a week, on weekends with special programming, or by request. The Foundation displays exhibits related to the themes previously cited, as well as contemporary fine art by artists currently or formerly associated with Natchez. The Foundation allows other non-profit and governmental entities to use the facilities of the Foundation's headquarters in the Natchez Institute at no charge for meetings and educational programming. In 2016, staff members invested time in assisting other non-profits in the preparation of grant applications and in the management of grant-funded projects. The Foundation mounted and hosted three major exhibits in 2016: "Coming Home: A Tribute to Renowned Natchez Artists," A Smithsonian traveling exhibit and local exhibit on sports history entitled "Hometown Teams;" and "Joe Johnson, An Artist's Interpretation of Natchez African American History."

4b (Code:) (Expenses \$ 142,739 including grants of \$ 10,000) (Revenue \$ 11,450) PRESERVATION-The Foundation works to preserve historic buildings, which sometimes involves acquisition and restoration. The Foundation places preservation easements in perpetuity on all historic properties that are acquired for preservation purposes before any resale of the property. The Foundation owned only four properties, one of which is a vacant lot, at the beginning and end of 2016. The Foundation solicits preservation and restoration grants and other funding and administers two funds dedicated to preservation and restoration activities-the Masterson Fund and the Whatley Fund. The Foundation serves in an advisory capacity to the Natchez Preservation Commission and works with the city to insure that public and private projects meet historic preservation guidelines. On a daily basis, the Foundation advises and assists architects, contractors, developers, craftsmen, organizations, and the general public on proper preservation and restoration methodology and on the design of new buildings to make them compatible within a historic context. The Foundation also assists citizens, accountants, lawyers, bankers, and developers on local, state, and federal issues and benefits related to the acquisition, development, and ownership of historic properties.

4c (Code:) (Expenses \$ 46,616 including grants of \$) (Revenue \$ 1,681) COLLECTIONS-(Foundation Archives, Artifacts, and Public Records)-The Foundation has a significant collection of important archival material, museum artifacts, and public records related to the history of the Natchez region. The Foundation's collections include books, photographs, documents, site files, subject files, public records, and artifacts. The archives and public records are made available on a daily basis to the public under the supervision of the Foundation staff. The Foundation maintains a research library with books and reference material on Natchez and regional history, Mississippi history, historic preservation, architecture, decorative arts, fine arts, and museum management. The Adams County Board of Supervisors has entrusted the Foundation with the care and management of public courthouse records dating to the 18th, 19th, and 20th centuries. The county began relocating Circuit Court records to the Foundation in 1992, and the program expanded in 2008 to include the Chancery Court records. The county provides a small amount of funding for records management. The Foundation has sponsored a program in conjunction with universities and the National Park Service to preserve and catalogue these valuable historic documents. Staff members continue to process records to preserve them and to build a comprehensive computer database to make them more accessible to the public.

To assist the City of Natchez, a non-profit 501(c)(3) organization titled FOR Natchez, pledged to raise \$80,000 toward the cost of hiring a professional planning firm with proven expertise in city planning for small historic towns. The comprehensive costs totaled \$100,000. To help the non-profit organization reach its goal, the Historic Natchez Foundation offered \$10,000 in matching funds to raise the final \$20,000 necessary to reach the \$100,000 goal. The planning firm was hired in 2016 and will finish the project before the end of 2017.

The deputy director has 12 years of experience in the field of historic preservation and started working for the Foundation on March 1, 2012.
