Birthright of Greater Hartford, Inc. offers services, aid and assistance to individuals who have problems with a pregnancy and desire a positive alternative to abortion.

Birthright's volunteer staff also offered community resource information and referrals.

~~Estimate (from previous year): 250 total callers. Of these, 66 community assistance callers and 194 crisis pregnancy callers.~~

Pregnancy tests were provided for 61 women and friendship counseling for 150.

83 babies were born to mothers we served. 33 mothers received maternity clothing and 37 babies received baby clothing.

Actual (not estimated): 18 mothers assisted in purchasing cribs and 20 in purchasing car seats. Friendship counseling volunteers staffed the office 35 hrs/wk and clerical and clothing volunteers 16 hrs/wk. Grant of \$12,000 to Birthright, International for USA helpline which is staffed 24 hrs/day, 7 days/wk.
