The programs and services offered provide access to information and support, as well as opportunities for participation in activities that lead to personal growth, improved health, and enriching life experiences.

RECREATION CCSCA provides weekly dances with bands and other entertainment, parties celebrating monthly birthdays and holidays, several movies each week, and a variety of other special events. In addition, the CCSCA facility includes a room with billiard tables, locations for games and for various club meetings, and in general is a welcoming space for informal socializing. CCSCA also organizes a number of trips to a variety of nearby and more distant destinations, both single-day and longer excursions.

HEALTH AND NUTRITION Low-cost, nutritious hot lunches are provided in the facility's lunchroom every weekday and also are delivered to home-bound seniors by volunteers. The expenses for this Senior Nutrition program are largely borne by the City of Culver City, but some CCSCA members volunteer to work in the lunchroom, and CCSCA contributes some financial support to the program. CCSCA itself provides low-cost snacks every weekday. Certificates for food purchase, supported by donations, are provided to seniors in need during the year-end holiday season. A well-equipped gym, staffed with monitors provided by the City of Culver City, is available to members of CCSCA, for a fee. Counseling services are available on-site, provided by local counseling programs.

COMPUTER AND OTHER CLASSES CCSCA has a fully equipped computer room, utilized for education and experience in computer use for seniors, as well as for classes on other technological topics and devices. Many other classes are offered as well, including yoga, Tai chi, and various languages.

OTHER PROGRAMS Presentations and seminars are held on health and financial topics of interest to seniors, as well as on practical matters like local bus transportation. CCSCA members are eligible for discounted taxi and Dial-A-Ride coupons, funded by the city of Culver City and the county of Los Angeles. Members, many of whom have mobility challenges, are able to park right outside the senior center, for a minimal annual fee intended to offset related costs. A newsletter detailing center activities, classes and presentations is prepared by the city and is available to members at no cost; it is distributed by mail upon request, for a small fee to cover the postage expense.
