The Organization primarily collects blood and blood products from voluntary donors. These products are processed and distributed to various public and private hospitals. The Organization collected 63,734 units of red blood cells and apheresis platelets from volunteer blood donors and prepared 76,316 transfusable components and 32,432 salvage components for remanufacturing from these collections of voluntary donors in 2016. The Organization distributed 88,867 transfusable blood components to public and private hospitals within the State of Mississippi and the surrounding states. The Organization performed 541 therapeutic procedures free of charge for members of the community who have been diagnosed with polycythemia vera. The Organization made monetary contributions of \$11,281 to other non-profit organizations. The Organization donated 43 used laptop computers to Jackson State University to use in training. The Organization provided 387 iron and blood pressure checks free of charge to area residents. The Manager of Hospital Relations hosted 10 continuing education meetings regarding blood transfusions to 118 laboratory staff from area hospitals. One member of management volunteered for two days at the MS Sickle Cell Foundation Annual Camp for 46 patients. The Medical Director and other staff members provided blood bank training to 2 medical technologist students from local hospitals.
