Its public support percentage is below 33 1/3% because the Foundation receives a high percentage of total support from the investment income that is generated by its investment accounts which are held by the its Trustee financial institutions. The Foundation's investment accounts are comprised of funds that were originally contributed by many donors who were representative of the general public residing in and around Warren County, Pennsylvania, from the year 1949 through the present time. The Foundation is governed by a board of directors that consists of seven members who reside in Warren County, Pennsylvania. The Foundation's governing Resolution and Declaration of Trust provides for one board member to be appointed by each of the following: presiding Senior Common Pleas Judge of Warren County, Warren County Bar Association, Mayor of Warren City, and each of the two Foundation Trustee financial institutions. Two additional members are elected by the five appointed board members. The Foundation makes hundreds of grants and educational scholarships each year to varying non-profit organizations and students in Warren County, Pennsylvania, based on local needs.
