THE ARMY HERITAGE CENTER FOUNDATION'S PRIMARY FOCUS IN 2016 WAS TO MANAGE THE CONSTRUCTION OF VISITOR AND EDUCATION CENTER EXPANSION AND THE RENOVATION OF THE RIDGWAY HALL LOBBY INTO A USEABLE SPACE. THIS EFFORT REQUIRED A SIGNIFICANT COMMITMENT OF TIME AND RESOURCES FROM THE FOUNDATION LEADERSHIP AND THE DEVELOPMENT STAFF. AT THE SAME TIME, THE FOUNDATION CONTINUED TO PROMOTE AND ENHANCE PROGRAMS OF THE U.S. ARMY HERITAGE AND EDUCATION CENTER, TO SUSTAIN THE FOUNDATION'S EDUCATIONAL PROGRAMS AND ITS OPERATIONS AND MEMBERSHIP AND VETERAN OUTREACH PROGRAMS. THE CONSTRUCTION OF THE VISITOR AND EDUCATION CENTER EXPANSION PROJECT, OR THE "HALL OF THE AMERICAN SOLDIER," BEGAN IN JANUARY 2016 AND WAS COMPLETED IN AUGUST 2016. THE PROJECT ADDED 7,500 SQUARE FEET TO THE FACILITY AND INCLUDED AN ADDITIONAL GALLERY, A DIVISIBLE MULTIPURPOSE ROOM, AND EXPANDED CAFÉ SEATING. THE U.S. ARMY ACCEPTED BENEFICIAL OCCUPANCY OF THE FACILITY IN SEPTEMBER 2016 AND FULL POSSESSION IN JANUARY 2017. THE FOUNDATION ALSO UNDERTOOK THE RENOVATION OF THE RIDGWAY HALL LOBBY. THE U.S. ARMY HERITAGE AND EDUCATION CENTER HAD IDENTIFIED A NEED TO MODIFY THIS UNDERUTILIZED SPACE THAT NO LONGER WAS USED AS THE FACILITY'S ENTRANCE. THE FOUNDATION PROPOSED TO RENOVATE THE SPACE TO PROVIDE A NEW GALLERY. THE PROJECT PROFFER WAS SUBMITTED IN DECEMBER 2015, APPROVAL OF THE PROJECT'S SCOPE OCCURRED IN MARCH 2016, AND WORK BEGAN IN JULY 2016. THE ARMY ACCEPTED THE COMPLETED PROJECT IN SEPTEMBER 2016. THE PROJECT'S DIRECT COSTS WERE 52,000. THE FOUNDATION ALSO CONTINUED TO PURCHASE ADVERTISING AND MARKETING MATERIALS IN REGIONAL TOURISM AND OTHER MEDIA OUTLETS. NEW PURCHASES IN 2016 INCLUDED ADVERTISING AT SIX (6) NASCAR RACES, REVISED DIRECTIONAL SIGNAGE TO USAHEC OFF INTERSTATE 81, ADVERTISEMENTS IN VIETNAM MAGAZINE, FACEBOOK ADS, AND VIDEO ADVERTISEMENTS IN THE PENNSYLVANIA TURNPIKE REST STOPS. ADDITIONALLY, THE FOUNDATION STAFF CONTINUED TO SUPPORT OUTSIDE PROGRAMS AND EVENTS TO PROMOTE USAHEC WHERE FEDERAL EMPLOYEES WERE UNAVAILABLE. THE MOST SIGNIFICANT OF THESE AGAIN INCLUDED THE PENNSYLVANIA AND MARYLAND BUS TOUR ASSOCIATION MEETINGS AND THE VII CORPS DESERT SHIELD/STORM ASSOCIATION MEETING. THE MEDIA PURCHASES AND ASSOCIATED PROMOTIONAL SUPPORT, TO INCLUDE NEGOTIATED IN-KIND SUPPORT, AMOUNTED TO MORE THAN 23,000 IN DIRECT AND INDIRECT SUPPORT TO USAHEC. THE FOUNDATION ALSO OBTAINED SUPPORT TO ENHANCE USAHEC PROGRAMS. THE MOST SIGNIFICANT NON-CONSTRUCTION ACTIVITY WAS ITS SUPPORT OF A 2016 EXHIBIT OF PENCIL SKETCHES BY JOHN A. COOK. COOK WAS A SOLDIER IN THE 1ST CAVALRY DIVISION DURING THE KOREAN WAR WHO SUFFERED FROM PTSD. HIS POST-WAR DRAWINGS SERVED AS AN ELEMENT OF THIS TREATMENT. THE FOUNDATION CONTRACTED FOR CURATORIAL STAFF AND FUNDED THE NECESSARY SUPPLIES FOR THE EXHIBIT. THE EXHIBIT OPENED TO THE PUBLIC IN JUNE 2016. ADDITIONALLY, IN COORDINATION WITH NATIONAL FILM DISTRIBUTORS, THE FOUNDATION COORDINATED THE SHOWING OF TWO FILMS AND ASSOCIATED PROGRAMS - THE OSCAR-NOMINATED FILM A WAR IN FEBRUARY 2016 AND THANK YOU FOR YOUR SERVICE IN SEPTEMBER 2016. THE FOUNDATION ALSO TOOK A MORE ACTIVE ROLE TO OUTREACH WITH POTENTIAL DONORS OF ARTIFACT, MANUSCRIPT, AND LIBRARY COLLECTIONS. MAJOR COLLECTIONS ACQUIRED IN 2016 INCLUDED ARTIFACTS AND MANUSCRIPT ITEMS RELATED TO MEDAL OF HONOR RECIPIENT MAJOR MATTHEW BATSON AND MORE THAN 15,000 IN LIBRARY MATERIALS. THE EDUCATION DEPARTMENT'S PROGRAMS CONTINUE TO PROVIDE ENHANCEMENTS TO USAHEC'S EDUCATIONAL MISSION THROUGH OUTREACH TO STUDENTS, TEACHERS, AND MEMBERS OF THE PUBLIC ON A LOCAL, REGIONAL, AND NATIONAL BASIS. SPECIFIC EFFORTS IN 2016 FOCUSED AGAIN ON THE NATIONAL HISTORY DAY IN PENNSYLVANIA (NHD IN PA), THE VETERAN'S ORAL HISTORY PROJECT (VOHP), ONLINE SOLDIER STORIES, INTERNSHIPS, AND THE SOLDIER EXPERIENCE LIVING HISTORY ADVENTURE CAMP. NEW INITIATIVES INCLUDE PROVIDING THE MEDAL OF HONOR CURRICULUM IN LOCAL SCHOOLS AND A VETERAN OUTREACH PROGRAM, THE VETERANS' CAFÉ. IN 2016, MORE THAN 12,000 STUDENTS AND 300 TEACHERS THROUGHOUT PENNSYLVANIA PARTICIPATED IN THE NHD IN PA PROGRAM. THE FOUNDATION PROVIDED SUPPORT TO OUR REGIONAL PARTNERS AND MANAGED THE STATEWIDE COMPETITION THAT ENGAGED MORE THAN 1,100 STUDENTS, TEACHERS, PARENTS, AND VOLUNTEERS IN THE EXPLORATION OF HISTORY. SIGNIFICANT NUMBERS OF NHD IN PA STUDENTS CONTINUE TO VISIT USAHEC TO UTILIZE THE COLLECTION FOR THEIR RESEARCH. IN PARTNERSHIP WITH CUMBERLAND VALLEY HIGH SCHOOL, THE VETERAN ORAL HISTORY PROGRAM AND SUPPORT TO OUR LOCAL NEWSPAPER, THE SENTINEL, VIETNAM SERIES, THE FOUNDATION RESEARCHED AND COLLECTED 30 ORAL HISTORIES AND PREPARED THEM FOR DONATION TO USAHEC. A NEW EFFORT IN 2016 INCLUDED THE IMPLEMENTATION OF ELEMENTS OF THE MEDAL OF HONOR SOCIETY'S CHARACTER DEVELOPMENT PROGRAM WITH MIDDLE SCHOOL STUDENTS IN CARLISLE, PA. STUDENTS LEARNED ABOUT THE MEDAL OF HONOR, STUDIED THE STORIES OF SPECIFIC RECIPIENTS, AND ENGAGED IN DISCUSSIONS OF THE VALUES REPRESENTED BY THE MEDAL AND THE ACTIONS OF THE Awardees. THE NEWEST PROGRAM, THE VETERANS' CAFÉ, BRINGS TOGETHER VETERANS OF ALL SERVICES AND ERAS TO ENJOY A MEAL TOGETHER AND SHARE STORIES OF SERVICE. OUR STAFF MEETS WITH FEATURED VETERANS AHEAD OF TIME TO RECORD THEIR ORAL HISTORIES, AND THE FOUNDATION IS CURRENTLY ENGAGED IN A FUND-RAISING EFFORT TO OBTAIN PROFESSIONAL QUALITY RECORDING EQUIPMENT TO ENABLE US TO RECORD DOCUMENTARY QUALITY FOOTAGE. BUSINESS OPERATIONS CONTINUED TO PROVIDE A SMALL BUT VITAL INCOME TO THE FOUNDATION. THE MUSEUM STORE CONTINUED EFFORTS TO TAILOR MERCHANDISE BETTER SUITED TO THE CLIENTELE AND TO CONTROL OPERATIONAL COSTS AND SALES INCREASED FROM CY2015. INCOME DURING THE YEAR FROM ALL SOURCES WAS 2,759,797 AND ITS EXPENSES WERE 2,894,032. THE FOUNDATION ENDED CY2016 WITH CASH RESERVES AND BOARD-DESIGNATED AND RESTRICTED ACCOUNTS OF 579,426. OUTREACH TO OUR MEMBERSHIP AND LOCAL SUPPORTERS AND THEIR BACKING OF SPECIAL EVENTS CONTINUED TO PROVIDE THE GREATEST SUPPORT TO THE FOUNDATION'S OPERATIONS. CONTRIBUTIONS OF BOTH GREW SLIGHTLY FROM CY2015. THE MAJOR DIFFERENCE IN 2016 WAS THE SUPPORT OF SEVERAL MAJOR CONTRIBUTORS WHO PROVIDED DONATIONS FOR SUPPORT TO THEIR EDUCATIONAL OR LEADER DEVELOPMENT PROGRAMS.

SIGNIFICANT NUMBERS OF NHD IN PA STUDENTS CONTINUE TO VISIT USAHEC TO UTILIZE THE COLLECTION FOR THEIR RESEARCH. IN PARTNERSHIP WITH CUMBERLAND VALLEY HIGH SCHOOL, THE VETERAN ORAL HISTORY PROGRAM AND SUPPORT TO OUR LOCAL NEWSPAPER, THE SENTINEL, VIETNAM SERIES, THE FOUNDATION RESEARCHED AND COLLECTED 30 ORAL HISTORIES AND PREPARED THEM FOR DONATION TO USAHEC. A NEW EFFORT IN 2016 INCLUDED THE IMPLEMENTATION OF ELEMENTS OF THE MEDAL OF HONOR SOCIETY'S CHARACTER DEVELOPMENT PROGRAM WITH MIDDLE SCHOOL STUDENTS IN CARLISLE, PA. STUDENTS LEARNED ABOUT THE MEDAL OF HONOR, STUDIED THE STORIES OF SPECIFIC RECIPIENTS, AND ENGAGED IN DISCUSSIONS OF THE VALUES REPRESENTED BY THE MEDAL AND THE ACTIONS OF THE AWARDEES. THE NEWEST PROGRAM, THE VETERANS' CAFE, BRINGS TOGETHER VETERANS OF ALL SERVICES AND ERAS TO ENJOY A MEAL TOGETHER AND SHARE STORIES OF SERVICE. OUR STAFF MEETS WITH FEATURED VETERANS AHEAD OF TIME TO RECORD THEIR ORAL HISTORIES, AND THE FOUNDATION IS CURRENTLY ENGAGED IN A FUND-RAISING EFFORT TO OBTAIN PROFESSIONAL QUALITY RECORDING EQUIPMENT TO ENABLE US TO RECORD DOCUMENTARY QUALITY FOOTAGE. BUSINESS OPERATIONS CONTINUED TO PROVIDE A SMALL BUT VITAL INCOME TO THE FOUNDATION. THE MUSEUM STORE CONTINUED EFFORTS TO TAILOR MERCHANDISE BETTER SUITED TO THE CLIENTELE AND TO CONTROL OPERATIONAL COSTS AND SALES INCREASED FROM CY2015. INCOME DURING THE YEAR FROM ALL SOURCES WAS 2,759,797 AND ITS EXPENSES WERE 2,894,032. THE FOUNDATION ENDED CY2016 WITH CASH RESERVES AND BOARD DESIGNATED AND RESTRICTED ACCOUNTS OF 579,426. OUTREACH TO OUR MEMBERSHIP AND LOCAL SUPPORTERS AND THEIR BACKING OF SPECIAL EVENTS CONTINUED TO PROVIDE THE GREATEST SUPPORT TO THE FOUNDATION'S OPERATIONS. CONTRIBUTIONS OF BOTH GREW SLIGHTLY FROM CY 2015. THE MAJOR DIFFERENCE IN 2016 WAS THE SUPPORT OF SEVERAL MAJOR CONTRIBUTORS WHO PROVIDED DONATIONS FOR SUPPORT TO THE IR EDUCATIONAL OR LEADER DEVELOPMENT PROGRAMS.
