The Beth C. Wright Center offers a variety of programs and services for people living with cancer and for their family members, caregivers, friends, and interested community members. All of these programs are offered at no charge at our Center in Ellsworth and other locations in Hancock and Washington Counties. These programs include classes in reiki, yoga, therapeutic exercise, reflexology, and other complementary therapies. The Center also facilitates support groups for people living with cancer in Ellsworth and other communities in Down East Maine. Working with other community agencies the Beth Wright Center organizes the Down East Living With Cancer Conference in Bar Harbor and the Washington County Cancer Conference in Machias. The Beth Wright Center also sponsors the Turning The Tide Retreat for women living with ovarian cancer held at Camp Kieve in Nobleboro, ME. This is a four day retreat that offers complementary therapies, outdoor activities, and a chance to share experiences with other ovarian cancer survivors. There is a charge for this retreat but financial assistance is available for those who need it.

4b (Code:) (Expenses \$ 27720 including grants of \$ 0) (Revenue \$ 0)
This total is the portion of the Executive Director's salary and the salary of the part-time Program / Volunteer Coordinator that is devoted to programs. The Executive Director is involved in recruiting instructors for programs, facilitating support groups, and informing people living with cancer about the programs and services of the Beth Wright Center. The Program / Volunteer Coordinator's job is to manage the volunteer program of the Center, develop new programs, and coordinate existing programs of the Center. Her duties include recruiting, training, and supervising volunteers. She also schedules the activities at the Center and facilitates many of the programs.

4c (Code:) (Expenses \$ 18181 including grants of \$ 18181) (Revenue \$ 0)
The Beth Wright Center awarded grants to people living with cancer to help them cope with the financial stresses that are the result of going through treatment for cancer. People use these grants to pay for their household bills such as heating bills, mortgage payments, rent, or car payments and repairs. The grant recipients also use these funds to help pay for the travel and housing costs incurred while receiving treatment for care. The Beth Wright Center serves a rural population and people often have to travel hundreds of miles a week to receive their cancer treatments.
