In 2016, The Food Basket Emergency Food program distributed over one million pounds of food to over 90 partner agencies serving an average of 13,649 unduplicated individuals per month over the course of the year. The Food Basket continued its SNAP Outreach services that made over 1,000 client contacts and enrolled 98 eligible clients in SNAP. The Community Supported Agriculture programs continued with DA BOX and Good Food for Everyone programs, that incentivize healthy eating by distributing produce to SNAP recipients at a discount. The Senior Produce program distributed fresh, locally grown produce to over 1,500 eligible seniors. The Keiki Backpack provided nutritious easy to eat food to 1,600 school children throughout the Big Island. The Food Basket also completed a \$546,000 capital campaign to improve a leasehold warehouse comprising of 6,344 square foot facility in Kailua Kona on the Big Island of Hawaii to enhance service to all on the West side of the island.
