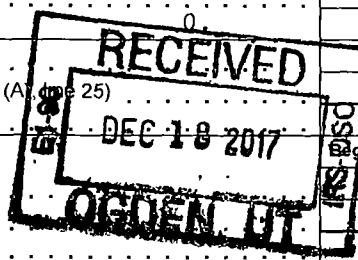

THERE ARE CURRENTLY A TOTAL OF 48 CHILDREN CATEGORIZED AS RECEIVING SUBSIDIZED CARE DUE TO THEIR ELIGIBILITY BASED ON INCOME. A TOTAL OF 9 CHILDREN HAVE BEEN GIVEN A 100 % SCHOLARSHIP. AS OF DECEMBER 31, 2016, THERE WERE 69 TOTAL STUDENTS ENROLLED IN THE SCHOOL.
