Foster Care Closet exists to help ease children's anxiety when being placed into Foster Care. We provide them with 5 sets of clothes (pants, socks, jeans, shirts, blouses, shoes) twice a year for spring/summer and fall/winter. We also provide an Intake Care Center where Case Managers can bring children at the time of removal and we support these children with meals, a cheerful setting, and new clothes while their Case Manager is reviewing placement options.

FCC gives clothes to children in the Foster Care System in Southeast Nebraska. We provide 5 sets of clothing (shirts, jeans/pants, socks, shoes, diapers, blankets, pajamas) to these children 2 times a year. This is once for spring/summer clothing and once for fall/winter clothing. In winter, we also try to provide warm jackets, mittens, and stocking caps. The State of Nebraska supports this program and has encouraged us to extend it to other cities in Nebraska. We are currently opening 2 additional sites in western Nebraska and will open 2 more in central and northeastern Nebraska in late 2017. This year we served 900 children through the Foster Care Closet in Southeast Nebraska.

Through the Intake Care Center, which is in a suite above the Foster Care Closet, we accept children that have been removed from homes. We provide space for the case manager to contact possible placements. While we are waiting for placements, we provide food for the children. We let them pack what comfort food they want. We also visit with them and try to reassure them that things will be OK. We let them select new clothes, provide a backpack, and generally provide an environment that is supportive of them during this traumatic time in their lives. Prior to establishing the Intake Care Center, children who were removed by police had to ride around in the back of a police car until a placement was found. This could last anywhere from 1 hour to 24 hours. At the Intake Care Center, we try to meet their immediate needs and help them understand that they are loved and respected and that it's OK to be scared but there are people who care for them and will help them in this next step in their life. Last year we served 175 kids at the Intake Care Center.
