Criminal Justice: Through its Criminal Justice initiative, the Southern Coalition for Social Justice (SCSJ) tackles racial discrimination at the legal and policy levels to eliminate obstacles facing those with criminal records as they attempt to re-enter the mainstream of society. In addition, the Youth Justice Project seeks to end the criminalization of youth through interventions in the juvenile justice and education systems.

Human Rights: Using a community-lawyering model, SCSJ levels the playing field to protect the civil, economic, and political rights in priority areas that are defined by the communities SCSJ seeks to serve.
