THE PROGRAM IS A PARTNERSHIP WITH THE FANNING INSTITUTE FOR LEADERSHIP DEVELOPMENT AT THE UNIVERSITY OF GEORGIA. THE GEORGIA CHAMBER SERVES AS THE HOST ORGANIZATION OF GEORGIALEADS WHILE THE FANNING INSTITUTE COMPLETES THE PROGRAM IMPLEMENTATION. ALSO IN 2016, THE GEORGIA CHAMBER FOUNDATION DEVELOPED A TASK FORCE TO WORK WITH A SERIES OF STAKEHOLDERS ON DEVELOPING A SERIES OF RECOMMENDATIONS FOR GEORGIA TO LOWER IT'S UNINSURED RATE. THE WORK WAS BUILT AROUND THE CONCEPT OF DEVELOPING A FEDERAL WAIVER FOR GEORGIA TO EXPAND ITS MEDICAID PROGRAM.
