

TIGRA sponsored a couple of convenings on the topic of Governing for Racial Equity to develop a community engagement strategy with the City of Oakland's Department of Race & Equity. TIGRA also published the Of Note Oakland Digest on Race which goes out weekly to opinion makers in the city.

TIGRA continued its Economic Citizenship program for Filipino newcomers and DACA recipients in San Mateo and Santa Clara counties, serving more than 100 participants in basic financial literacy for immigrants. Our work with DACA applicants included assistance with their application forms. However, the program was curtailed at the end of 2016 with the new Administration.

Engaged youth refugees from Central America in a mentoring program with college students from UC-Berkeley and San Francisco State University. Twelve recent arrivals from Guatemala and El Salvador went through the program to assist in their integration in their new home. TIGRA, along with the Vietnamese Chamber of Commerce, sponsored a Welcoming Luncheon for 200 refugees from the Middle East, Africa, and Asia who expressing fear of their status.
