The organization also conducted two orphan conferences with 20 staff /volunteers and 200 residents/graduates of the orphanages. Weekly and monthly meetings were held to provide training for life skills with the orphans via an English Club, Graduate Club, Legal consultations, Young Mom's Club, Cooking classes, Creative classes, Communications club, Pregraduate counseling, Staff leadership training, and Thai boxing.
